- The probability of building up a report for each patient case in the wellbeing community.

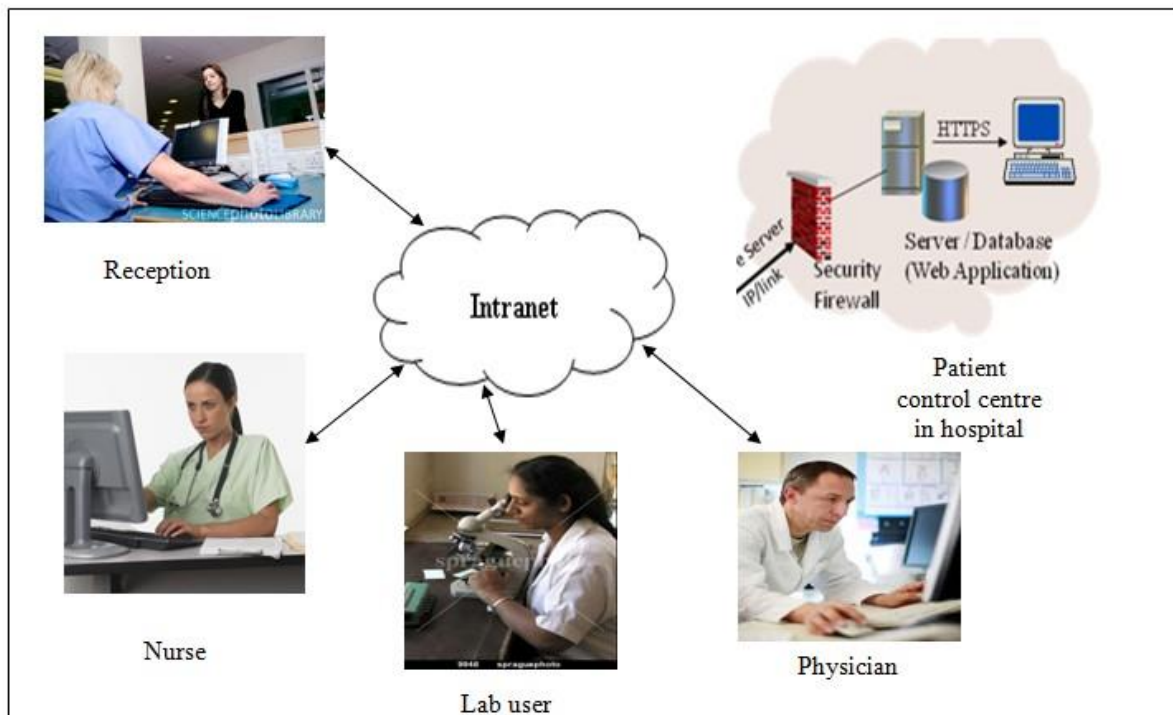


Figure 1.1: System architecture for EPRMS

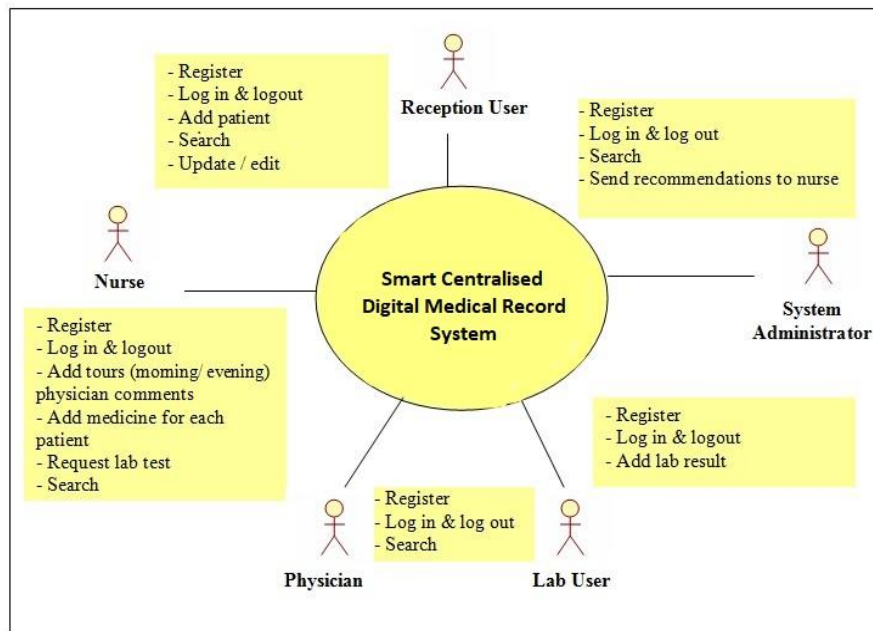


Figure1.2: Scope of EPRMS

- HTML is the language for creating webpages .HTML files is the latest version. It is the markup language and have its own sets of predefined tags.

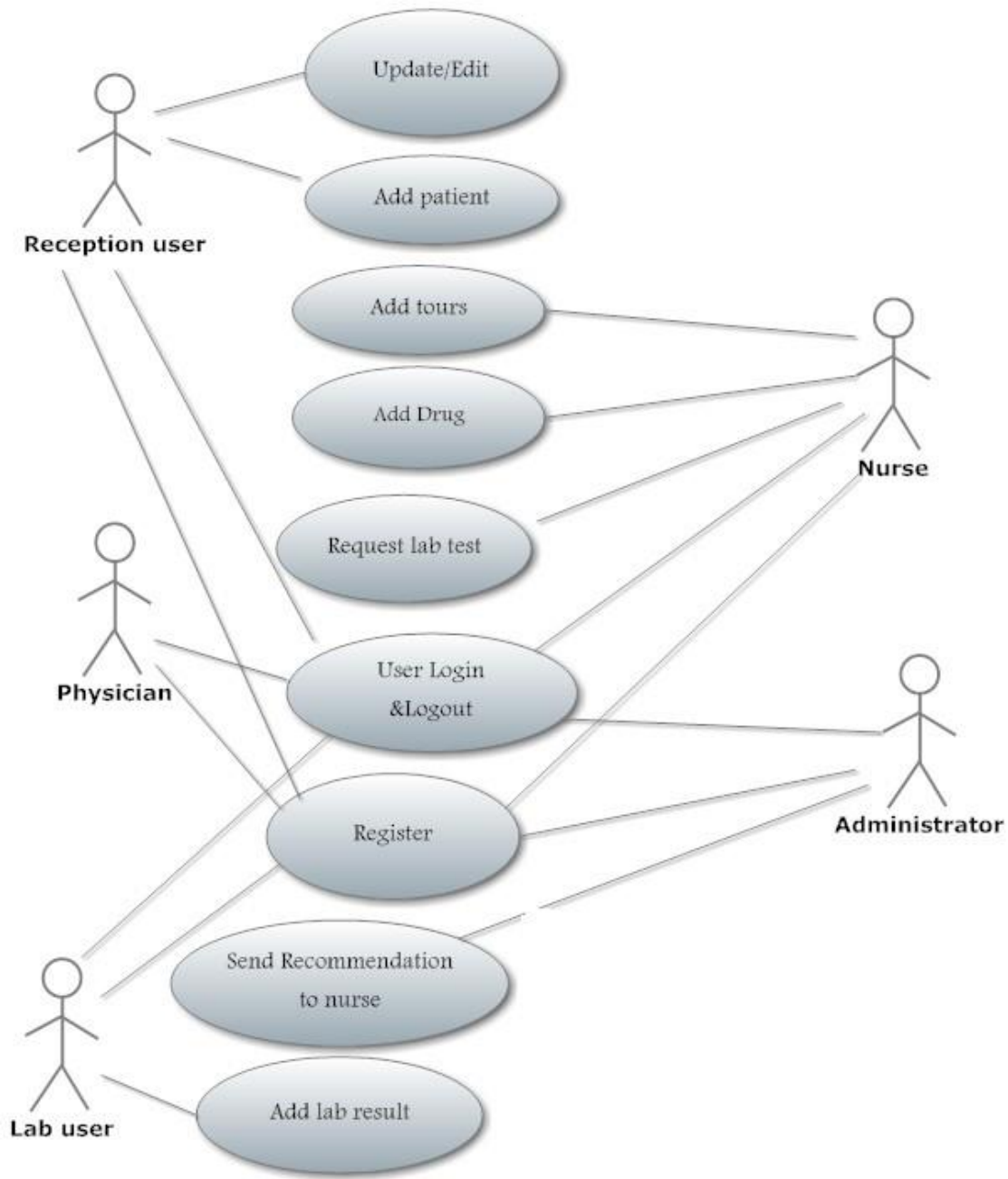
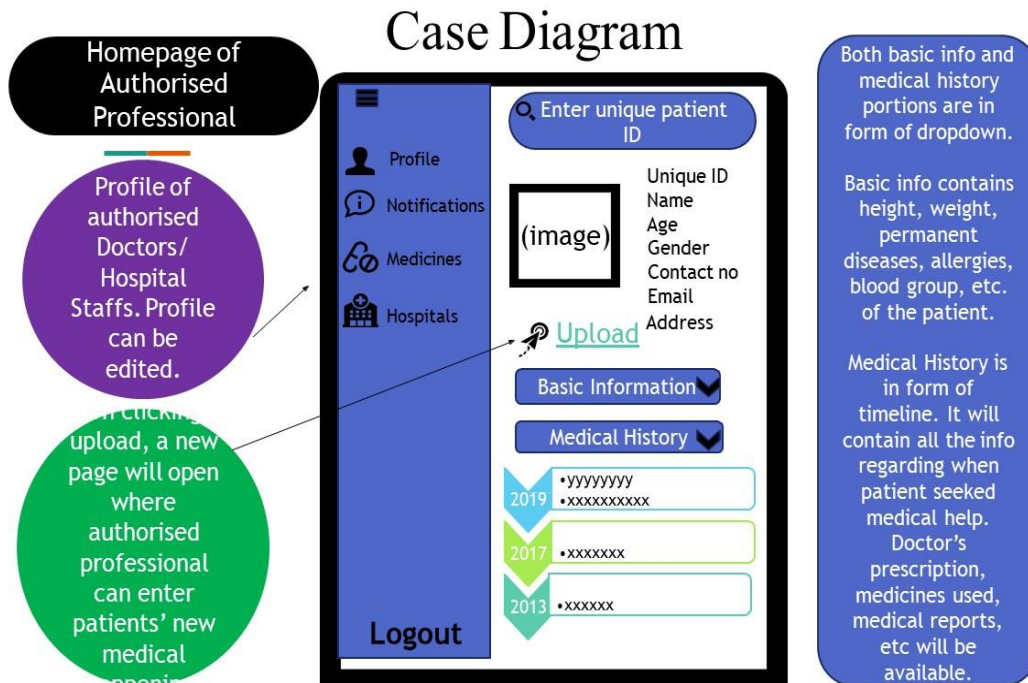


Figure (3.1): user's functions
